

# The Great Cash Grab

Financial Plus Credit Union will be giving away \$75,000 between 5/22/2026 and 12/31/2026 through the FPCU Money Machine CASH GRAB to randomly pulled members who enter to play. The machine will have \$750 in bills to be won, plus one specially marked bill worth \$7,500. If the special bill isn't grabbed by a winner in their round, it is then worth an additional \$7,500 for each following player until it's grabbed up to a total value of \$75,000. After the special bill is grabbed, its value starts over at \$7,500 for the following CASH GRAB player. The contest will continue until the entire \$75,000 has been given away.

Starting with our 75<sup>th</sup> anniversary event on 5/22/2026, members at all five locations can enter to win their chance in the FPCU Money Machine CASH GRAB. On 5/25/2026, the first 5 winners will be randomly pulled, with one winner from each of our five locations. Each winner will have one month from when they are randomly selected to schedule their turn in the money machine or assign someone to take their place. After the first five winners have been chosen, members must reenter every month to be eligible for the following monthly drawings of one winner per month from all five branches combined. Winners will be pulled the last Friday of every month until the total of \$75,000 has been given away.

\*This promotion is offered through FPCU and is available to FPCU members only. No purchase necessary. Odds of winning depend on the number of entries. The winner gives their permission to publish their name and photo. Prize value may be taxable; winner is responsible for applicable taxes. Other restrictions may apply.

## Official Rules

1. Must be 18 or older to enter
2. Open to Financial Plus Credit Union members only
  - a. Membership open to:
    - i. Anyone living or working in Bureau, De Kalb, Grundy, Lee, Kankakee, Kendall, LaSalle, Livingston, Putnam, and Will counties.
    - ii. Relatives of a current member by blood, adoption, or marriage are eligible to join FPCU.
3. NOT Eligible: Financial Plus Credit Union Employees and Board of Directors including immediate family and those residing in the same household. Specifically: Spouse, domestic partner or significant other, child, parents, siblings...all including steps. In-laws, grandparents, grandchildren, plus anyone living in the same household even if not related.
4. The giveaway will run 5/22/2026 to 12/31/2026 or until the entire \$75,000.00 has been given away.
5. No purchase is necessary to participate
6. Visit any branch starting 5/22/2026 to enter.
7. One entry per month per member and a new entry is required every month to be eligible for each month's CASH GRAB.
8. Odds of winning depend on the number of entries received.
9. Total amount available to each participant will be determined by whether the special bill worth \$7,500.00 is awarded or rolls over to the following participant.
10. Winners give their permission to publish their name and photo.
11. Prize value may be taxable; winner is responsible for applicable taxes.
12. All winners are randomly chosen from member submitted entries.
13. Member names and phone numbers will be collected and used only for selecting and contacting participants. After each round, entries will be shredded and not used for any future reason.
